## **MINUTES**

# DEFINED CONTRIBUTION

## I. ATTENDANCE, QUORUM, AND CALL TO ORDER

After determining a quorum was present, the Retirement Fund Board of Trustees Regular Meeting for the Defined Contribution Plan was called to order at 12:33 p.m. Friday, September 2, 2022, in the Retirement Fund Conference Room. Chairman Wilfred P. Leon Guerrero officiated.

## II. ELECTION OF OFFICERS

Director Paula Blas stated that based on the By Laws for the Board of Trustees, the Election of Officers is conducted every two (2) years. ## V. DIRECTOR'S REPORT - EXECUTIVE SUMMARY

1. Standard Insurance - An updated summary report as of July 31, 2022 on the status of applications and individuals on Group Long Term Disability (LTD) is provided for the Board's information. Director Blas stated that there are 41 active claims as of July 31, 2022.

#### Financial Report

- 1. Contributions Director Blas stated that as of August 30, 2022, all agencies are current with their Fiscal Year 2022 employee and employer contributions.
- 2. Financial Statements Director Blas stated that the books for the month ended July 31, 2022 were closed on August 26, 2022. The books for the month ended August 31, 2022 are scheduled to close on September 23, 2022.

### VI. THIRD PARTY ADMINISTRATOR'S REPORT

## A. Contribution Report – July 2022

Director Blas stated that Bjorn Hauerbach, Director, Client Relations & Participant Engagement, Empower Retirement, provided the TPA Report for the month ended July 31, 2022 on the DC Retirement System 401(a) Plan and the 457 Deferred Compensation Plan.

Mr. Hauerbach stated that the 401(a) Plan had total assets of \$453,208,779.30. There was an increase of \$27,314,440.91 or 6.41% from the previous month. The market effect was 5.72%. The 457 Plan had total assets of \$122,100,709.42. There was an increase of \$7,654,285.73 or 6.69% from the previous month. The market effect was 5.89%.

Mr. Hauerbach stated that the 401(a) Plan had total contributions of \$2,958,453.06. There was a decrease in contributions of \$81,276.62 or -2.67% from the previous month. The 457 Plan had total contributions of \$908,055.61. There was a decrease in contributions of \$355,719.01 or -28.15% from the previous month.

Mr. Hauerbach stated that the 401(a) Plan had disbursements totaling \$1,951,782.49. The 457 Plan had disbursements totaling \$709,887.58.

Mr. Hauerbach stated that the 401(a) Plan has a total of 6,762 participants receiving employer contributions. The 457 Plan has 5,499 actively contributing participants. The 401(a) Plan has 113 first-time contributors and the 457 Plan has 34 first-time contributors. Mr. Hauerbach stated that there were 10 retirees in the month of July; of the 10 retirees, 3 elected a full withdrawal, 2 elected a partial distribution, 3 elected a series of periodic payments, and 2 elected no distribution. Mr. Hauerbach pointed out that there were 380 walk-ins and 520 other participant engagements for a total of 900 engagements in the month of July.

Mr. Hauerbach provided the following updates:

- Rebrand within Empower now employees of Empower and no longer Empower Retirement. A bigger change is Great-West is also now called Empower.
- Prudential Life Acquisition there's going to be a company created called Empower Annuity Services effective October 2, 2022.
