#### II. REVIEW AND APPROVAL OF BOARD MINUTES

A. February 16, 2024 Regular Meeting

Trustee David Sanford, seconded by Trustee Thomas San Agustin, moved to approve the Minutes of the February 16, 2024 Regular Meeting, subject to technical corrections. Without objection, the motion passed.

#### IV. DIRECTOR'S REPORT - EXECUTIVE SUMMARY

1. Candelaria Rios, et al. vs. Joseph Ada, et al. (Special Proceeding Case No. SP206-93) - The Retirement Fund maintains a list of deceased COLA Awardees who did not name a beneficiary, or whose beneficiary may be deceased. COLA award disbursements for these individuals will be made to their respective estates. The Retirement Fund published a list of deceased COLA Awardees with the department they retired from on February 2, 2024 in the Guam Daily Post and on the GGRF website. As of Friday, March 8, 2024 there has been 80 individuals who have called in on behalf of the names that were published. A second publication will be in June 2024.

Acting Chair Leon Guerrero inquired on the 80 inquires that were received have they been validated and verified. Director Blas stated not all of them have been verified, individuals who inquired may not match those listed as a beneficiary. If the benefits are being paid to an estate, they will complete the forms that are required for The Small Estate Affidavit.

#### Financial Report

- 1. Contributions Director Paula Blas stated that as of March 13, 2024, all agencies are current with their Fiscal Year 2024 employee and employer contributions.
- 2. Financial Statements Director Blas stated that the books for the month ended February 29, 2024 are scheduled to close on March 29, 2024.
- 3. Fiscal Year 2024 Retirees' Supplemental Benefits Director Blas stated that supplemental benefits for retirees and survivors for the month of March 2024 will be paid by the end of the month.
- 4. Fiscal Year 2024 Medicare Reimbursements Director Blas stated that the Retirement Fund received the March 2024 allotment from the General Fund and reimbursements were processed accordingly.
- 5. **Defined Benefit 1.75 Plan** Director Blas stated that there were 2,028 members who transferred from the Defined Contributions 401(a) Plan to the Defined Benefit 1.75 Plan totaling

\$134,000,000 and of those 2,028 there are 991 of those members with an excess balance in their Defined Contribution 401(a) Plan accounts.

# B. Members and Benefits Committee

Trustee George Santos presented the Committee's March 2024 report to the Board of Trustees.

Trustee George Santos, seconded by Trustee Thomas San Agustin, moved to approve the recommendation of the Members and Benefits Committee contained on Pages 4 through 14, based on the Committee's review and findings of the March 2024 report. Without objection, the motion passed.

#### **DISABILITY CASE**

#### 1. Disability Case No. 23-003

At this time Acting Chair Leon Guerrero asked if any applicants were present at this time. Director Blas stated no applicants were present during this time. Vice Chair Leon Guerrero stated the application was picked up on February 4, 2022, the application was received on August 3, 2023, and was completed on February 20, 2024 when the second medical evaluation was received. The applicant is a 57-year-old, Utility Administrative Assistant with GWA with 21 years and 10.5 months of service.

The reason for the application is end stage renal disease and numbness of hands and feet. The applicant was examined by two Independent Medical Examiners (IME's): Dr. E. Schroeder on November 16, 2023 and Dr. D. Lim on February 9, 2024. Dr. E. Schroeder estimates the impairment of the whole person at 83%, indicates the impairment to be permanent and will preclude the applicant from work. Dr. E Schroeder noted that the impairment is permanent unless she seeks a renal transplant. Dr. D. Lim estimates the impairment of the whole person at 100%, indicates the impairment to be permanent and will preclude the applicant from work. Acting Chair Leon Guerrero states that based on the findings and recommendations of the two Independent Medical Examiners (IME's) she recommends the approval of Disability Application 23-003.

Acting Chair Antolina Leon Guerrero, second by Trustee George Santos, moved to approve a full disability pension for Disability Case No. 23-003, based on the findings of the two (2) Independent Medical Examiner (IMEs), and the review of records. Votes as follows: Yes Votes – Trustee David Sanford, Trustee George Santos, Trustee Thomas San Agustin, and Acting Chair Leon Guerrero. With four (4) "Yes" votes, the motion unanimously passed.
