#### MEDICARE PREMIUM REIMBURSEMENT PROGRAM

- 1. In order to receive a reimbursement of the Medicare premiums you pay, you must:
  - a. Reside, and file Income Tax Returns, on Guam;
  - b. Be enrolled in Medicare Parts A & B;
  - c. Provide proof of Medicare premium payments.
- 2. Enrollment in the GovGuam Health Insurance Plan is not required. However, if you choose to enroll in the GovGuam Health Insurance Plan, reimbursement shall only be made to those who opt for the Retiree Supplemental Plan (RSP).
- 3. If you will be turning sixty-five (65) years of age during the FY2024 Plan Year (October 1, 2023 to September 30, 2024), please seek Medicare counseling by contacting the Department of Public Health and Social Services, Division of Senior Citizens at 735-7421 or 735-7415.
